The Office of Permitting and Compliance (OPC) has completed review of the information provided in the referenced water well notification submittal(s). Based on pertinent data available to this office for the area surrounding the well location(s), it has been determined that proposed water withdrawal from the well(s) should not adversely affect water withdrawal from other registered water wells in the area or to the sustainability of the aquifer. However, be advised that there may be unregistered water wells in the surrounding area. Should you experience or receive any reports of water level decline in your own or nearby water wells, please notify OPC so that this Office may continue its Notification review process.

Groundwater Resources Well Number(s) **40-0252** has been assigned to your well(s). This number should be included on the water well registration form. LAC 43:VI.703.B requires that you notify OPC of any change in well information including but not limited to well use, pumping rate, construction information, or if well is not installed. All Information Change Notifications shall be submitted to this office with an amended Water Well Notification form (DENR-GWR-01) at least sixty (60) days prior to using the well for its intended purpose. Note, there may be additional permitting and/or approvals required prior to the installation of your well from federal/state/local offices.
